# Changes in the management of SCANLAB

The hidden champion for laser scanning systems appoints Dr. Alexander Roth as CEO and Alexander Staudt as COO

After earning his doctorate in physics, Alexander Roth gained valuable industrial experience at corporates such as Siemens and Giesecke & Devrient before discovering his passion for the photonics industry. He then held various positions at Rofin Baasel Lasertech, Coherent-Rofin and the Fraunhofer Gesellschaft. For the past five years, he has served as Managing Director of Coherent's Industrial Systems business unit. "With Dr. Alexander Roth, we have gained an industry expert, an experienced manager and a personality who fits perfectly into the company. The last few weeks of working together have shown me that we made the right decision," reports Georg Hofner. "I wish my successor every success in continuing our growth strategy and look forward to working with him in the future and exchanging ideas on a regular basis."

Alexander Staudt will assume the role of COO in January 2025, having overseen operations since 2023. An industrial engineer with 20 years of experience in electronics production, he was most recently plant manager and authorized signatory of the Würth Elektronik Group, specializing in printed circuit board production. Digitalization and process optimization are critical for SCANLAB's future success and are areas where
